## OUTSTANDING PUBLICATION AWARD

### Instructions for completing the nomination form for the 2017 Outstanding Publication in Astrostatistics and Astroinformatics award

#### Publication awards categories:

- IAA Outstanding Publication in Astrostatistics and Astroinformatics (1)
- IAA Outstanding Publication in Astrostatistics and Astroinformatics by a Post Doc (2)
- IAA Outstanding Publication in Astrostatistics and Astroinformatics by a Student (2)

#### EXCERPTS OF REGULATIONS REGARDING ELECTION

1. Annual Outstanding Publications awards will be presented on the basis of distinguished contributions to new knowledge and for promotion and application of Astrostatistics &/or Astroinformatics to the worldwide astrostatistics and astroinformatics community. Awards shall be made on the basis of their scientific contributions in terms of documentation, publications, patents etc. Researchers who have outstanding research work to their credit, may be nominated and be considered for this award.
2. A maximum of one Outstanding Publication by Faculty Member/Scientist is to be awarded, and two Post Doctoral and two Students Outstanding Publication awards may be presented in a given year. The publication awards do not have to be ratified, but are awarded directly by the awards committee.
3. **Any IAA member ( other than those in the current Award Committee)** may nominate or second up to three candidates each year for a category of an IAA Outstanding Publications award. The Nominations are to include supporting statements and evidence on behalf of those nominated for the award. Nominations are to be submitted no later than the **15<sup>th</sup> April**. Self nominations are not allowed.
4. Nomination papers should be received in the Association by the 15th April every year, duly completed and signed, and addressed to the Chair of the IAA Awards Committee. Nomination forms submitted after this date will not be considered. If the 15th April occurs on a postal holiday, nominations received the next working day will be accepted.
5. The nominator should preferably belong to or be highly knowledgeable in the same field of specialization as the nominee; and he/she shall certify that he/she is personally acquainted with the scientific contribution of the candidate.
6. Any candidate who canvasses for support for his/her candidature, shall be disqualified from election.
7. A list of scientists duly nominated with their qualifications shall be compiled from the nomination papers by the Award Committee. The Award Committee will vote from among those Publications nominated and shall approve the Outstanding Publication and award winners in each category within **1<sup>st</sup> July** of the year.
